a. Jay Kullman called the meeting to order at 6:00 pm.

#### 3. Approve Meeting Minutes:

- a. Rick Kaminski made a motion to approve the April 15, 2024 Regular Meeting Minutes. Keith Cappellini seconded the motion. The motion carried.
- b. Rick Kaminski made a motion to approve the May 3, 2024 Special Meeting Minutes that were related to the towns line of credit only. Keith Cappellini seconded the motion. The motion carried.

### 6. Review and Approve Liquor License(s):

- a. Jay Kullman made a motion to approve Echo Lake Inn Resort, Inc as well as Whetstone Station Restaurant & Brewery, LLC permit requests. Rick Kaminski second the motion. The motion carried.
- 7. Review and Possibly Approve Cost for Placement of American Flags on Poles in Plymouth:
  - a. Keith Cappellini made a motion to approve the purchase of 35 3x5 American Flags thru Allegiance Flag Supply that will be placed on the telephone poles in Plymouth with an approximate cost of \$4,856.25. Rick Kaminski seconded the motion. The motion carried.
- 8. Ratification of the M&T Bank Line of Credit Current Expense Note and Exhibit A:
  - a. Jay read the following: Regarding the Town of Plymouth Current Expense Note (Line of Credit), I move the Select Board to Ratify that Exhibit A, the SOFR Rate Rider, is incorporated as referenced in the Current Expense Note that the Select Board approved at a duly warned meeting held on Friday, May 3, 2024 at 8:30 am in the town auditorium and signed by Jay Kullman, Chairman of the Select Board and Elaine Pauley, Treasurer.
  - b. Jay Kullman made a motion to read documents and accept rider. Rick Kaminski seconded the motion. The motion carried.

### 9. Review of Grader Quote:

a. Rick Kaminski gave an update on the new grader cost. The cost of a new Caterpillar 120 AWD Joystick Machine is \$369,900.00 less \$30,000 (Caterpillar 130G Trade) for a net cost of \$339,900.00. It was agreed to table the decision on the grader until a later date.

#### 10. Animal Control Officer / Nuisance Dog Hearing:

a. Jay Kullman said that this would not be discussed as no one was in attendance to have a discussion.

#### 11. Discussion on Benefits for Employees:

a. Jay Kullman moved this to Executive Session.

#### 12. Reminder of Billings Road Bridge Closure:

- a. Rick Kaminski gave an update on Billings Bridge. Part of the initial project was quoted as minor work to the deck needed; however, after getting in there it will be more than extensive. They will pour three (3) inches of overlay. We are waiting for the quote, but cost will be approximately \$220,000 or \$230,000 plus change order. He added that we have to pay it then seek reimbursement as we did receive a grant for approximately \$200,000. Repairing the hydrant is part of the work being done by Daniels.
- b. Jay Kullman did add that the Patch Brook Bridge engineering services came in higher because a survey has to be done. The cost is going to be approximately \$5,000 which is \$3,500 more than originally budgeted for.
