The Board of Abatement of the Town of Plymouth, Vermont, notified and warned, met in the Meeting Room at the Municipal Building at 68 Town Office Road, in said Town on Monday, July 29, 2024, at 5:30 pm.

Abatement Hearing(s):

Pursuant to Title 24 V.S.A. § 1535, the following hearing(s) took place to consider the abatement of real estate and personal property taxes assessed.

1. <u>Call Meeting to Order:</u>

- a. Karen Evans called the meeting to order at 5:30 pm.
- 2. Consideration of Any Changes, Additions, or Removals to Agenda:

3. Approve Meeting Minutes:

- a. Karen Evans made a motion to approve the July 16, 2024 meeting minutes. Jay Kullman seconded the motion, and the motion carried.
- 4. Tax Abatement Hearing(s):

Parcel ID: 000798 - Pierson, Michael - 1276 Dublin Road, Plymouth - Residential

Karen Evans opened by stating the name of the Appellant, property address, and parcel ID number. Karen read the Oath to the Appellant. He acknowledged. Karen also asked if any Board Members had any conflicts. None we acknowledged. The Abatement form was completed and provided by William Pierson. The Town Clerk provide the 2024 tax bill as well as past due balances. Mr. Pierson stated that he had no income and that he had been trying to get social security/disability for several years, but wasn't having much luck. Mr. Pierson also stated that he has not filed an HS-122 form because he has not filed tax returns because of his lack of income. Karen Evans re-opened by stating the name of the Appellant(s), property address, and parcel ID number at 5:52 pm. Karen noted that Joyce Cooper gave permission for herself, Rick and Natasha to go out and look at the property. Karen Evans wrote up a site-inspection report and read it at the hearing. There was a discussion with regard to the washed out, private leach field and an estimate was provided. There was also a discussion about access to the property. Karen Evans asked if anyone had any questions or comments Nobody had anything else to add. Shawn Bemis made a motion to close the hearing at 6:02 pm. Natasha Bochkov made a motion to the Board that we follow the same process as we did last year for the flood victims when we abated their real estate taxes. The amount for 2023-2024 is \$39.74 and the amount for 2024-2025 is \$46.78. Angela Kissell seconded the motion, and the motion carried.
