CULVERT INSTALLATION AT CROWN POINT RD

The Town of Plymouth is seeking qualified contractors to install a pipe arch culvert with the following specifications:

- Clear Span: 128 inches
- Height: 83 inches
- Invert Burial: 2 feet
- Clear Height: 4.9 feet above streambed
- Waterway Area: 43.0 square feet
- **Bed Retention Sills:** 12 inches high at the edges, 6 inches high in the center, spaced no more than 8 feet apart, with one sill at the inlet and outlet.
- Fill Material: E-Stone, Type II
- Headwater Depth: 3.0 feet at 4% AEP, 4.0 feet at 1% AEP

Scope of Work:

Contractors must provide all labor and equipment, and permits necessary to complete the following tasks:

- Site Preparation: Clear and grade the site for culvert installation.
- **Excavation:** Excavate a trench to accommodate the culvert, including bedding and backfill.
- **Culvert Installation:** Install the pipe arch culvert, concrete blocks ensuring proper alignment and support.
- Bed Retention Sills: Construct and install bed retention sills as specified.
- **Backfill:** Backfill the trench with E-Stone, Type II, to the required level.
- Erosion Control: Implement erosion control measures as necessary.

Proposal Requirements:

Proposals must include the following:
