6. Emergency Bridge Repairs (20 mins allotment):

After the introduction of guest speakers, a slide presentation was shared for the purpose of the meeting and what they planned to review. Six bridges will be replaced over the next three years, two a year with no two being replaced at the same time. The project engineers discussed why the bridges needed replacing, how long they would take, the detour routes, and the impacts to traffic during future storm events.

Residents had the opportunity to ask questions and share concerns of the upcoming projects which consisted of the following: alternative routes during the construction, the impact of employees who work at business in town to include the customers who would utilize those businesses, (the loss of revenue), and the lack of accessibility for emergency vehicles to have access in Plymouth. The biggest question asked was why are we having the one bridge on 100 (#108) heading south closed completely? Residents were hoping to hear of a one way with traffic to at least keep traffic flowing.

One of the project staff came around asking for emails so we could receive notifications and updates as the projects are in process. Booklets were left review with addition sign-up sheets.
